

Portfolio Update

December marked the close of a robust year for risk assets, though equities saw some pressure as expectations for US monetary policy moderated. In Australia, the Reserve Bank of Australia (RBA) kept the cash rate steady at 4.35% during its December meeting, accompanied by a dovish statement. Bond markets were mixed with Australian long term yields rising slightly as the curve steepened while US yields saw sharper increases. PCI's near zero duration continues to minimise the impact of ongoing bond yield volatility as investors try to price the path of monetary policy easing.

Domestic spreads remained stable throughout December, capping a strong year for credit. Despite periods of elevated offshore volatility, domestic credit has continued to benefit from accommodative monetary policy, resilient economic conditions and low default rates. The Trust's credit spread return detracted slightly from return during December. The main detractor was the Trust's exposure to a term loan from Star Entertainment which has been revalued over recent periods in recognition of ongoing liquidity concerns. Perpetual prioritises valuation transparency and regularly values private assets held in the Trust utilizing an external provider. Changes to the fair value of these assets are reflected in the daily NTA.

Negative credit spread return was more than offset by the Trust's running yield. Income return remains the most substantial contributing factor to performance. The Trust continues to collect a healthy yield premium above the RBA cash rate, led by allocation to non-financial corporate loans alongside contributions from securitised assets and domestic banks. At month end, the Trust's running yield was 7.8%.

December is historically a quiet month for primary issuance and the Manager was selective in adding new issues to the Trust. PCI took part in a pair of new corporate hybrid deals from Pacific National and Ampol. The deals met strong investor demand, realising a tailwind from the forthcoming changes to bank hybrid capital.

Our proprietary credit outlook score improved through early December to reach neutral territory for the final reading of 2024. US high yield spreads are trading below the fair value range and AU swap spreads remain very tight. Supply and demand indicators have moderated although the high volume of recent issuance continues to weigh on the outlook.

The Trust is defensively positioned and retains the capacity to take advantage of relative value opportunities as they arise.

The Trust will diversify exposure and will have maximum exposure limits to issuers.

Typical investments will include corporate bonds, floating rate notes, securitised assets and private debt (for example, corporate loans).
