having to wait for deployment and utilisation to ramp up. It also presents Prophecy with a significant revenue opportunity without the need to complete conventional buying cycles.

Securonix will provide its existing customers the option to migrate from their existing third-party solution and onto Snare as their subscriptions expire over the first 12 months from the commencement of the partnership, and will give new customers the option to purchase Snare.
