MedicAlert Foundation and Careteg Announce Strategic Partnership to Enhance Medication Safety for Australians

Careteq Limited (ASX: CTQ) ("Careteq" or "the Company"), a clinical healthtech company specialising in innovative medication management and clinical governance solutions, is pleased to announce that MedicAlert Foundation Australia ("Medic Alert") and Careteq have entered into strategic partnership aimed at improving health outcomes for Australians living with complex medical conditions. The collaboration brings together MedicAlert's trusted medical identification services with Careteq's comprehensive medication management expertise.

The collaboration addresses a critical healthcare challenge: medication-related harm. With one in two older Australians taking five or more medications 1 2 3, and an 88% likelihood of adverse drug reactions in this group⁴, the partnership offers timely solutions for medication safety.

Recent data from the Australian Commission on Safety and Quality in Health Care highlights a concerning gap in medication review services, particularly among older Australians living in the community. Only 5.4% of Australians aged 75 years or older received either a Home Medication Review (HMR) or a Residential Medication Management Review (RMMR) in the past year⁵. This represents a significant shortfall, with over 500,000 at-risk individuals not receiving the medication reviews they need. Australians living in the community are less likely to receive a medication review⁶ compared to Australians living in aged care home.

The MedicAlert and Careteq partnership aims to address this disparity. Under the partnership, members and customers of both organisations will gain enhanced access to critical healthcare services. MedicAlert members will benefit from Careteq's medication management services, in particular, Home Medication Reviews (HMRs) through HMR Referrals. Similarly, Careteq's clients will receive information about, and access to, MedicAlert's life-saving medical identification products and 24/7 emergency response service.

"This partnership represents a significant step forward in our mission to protect Australians with chronic health conditions," said Chris Radbone, CEO of MedicAlert Foundation Australia. "By combining our emergency identification services with Careteq's medication management expertise, we're creating a more comprehensive safety net for our members."

Mark Simari, Executive Chairman of Careteq, added, "Our partnership with MedicAlert aligns perfectly with our goal of preventing medication-related harm. By raising awareness of the benefits of HMRs, we hope to enhance health outcomes for all Australians."
