### **ASF BECOMES DEBT FREE**

ASF Group Limited (“**ASF**”) is pleased to announce that it has executed a Debt to Equity Conversion Deed (“**Conversion Deed**”) with Star Diamond Developments Limited (“**Star Diamond**”), pursuant to which Star Diamond has agreed to convert all outstanding loans including accrued interests due by ASF under a \$25 million unsecured convertible loan facilities granted by Star Diamond (“**Convertible Loan Facilities**”) into 100% equity of ASF Resources Pty Ltd (“**ASFR**”), a wholly owned subsidiary of ASF, which holds 68.97% interest in Civil & Mining Resources Pty Ltd (“**CMR**”).

Upon completion of the Conversion Deed, all outstanding loans, including accrued interests, due to Star Diamond under the Convertible Loan Facilities amounting approximately \$22 million (after the assignment to Star Diamond of the loan due by CMR to ASF of approximately \$9.6 million) will be fully discharged. The Convertible Loan Facilities will be terminated forthwith and will have no further force or effect. The board of directors of ASFR will be restructured accordingly.

#### ***Information about ASFR***

ASFR, a 100% owned subsidiary of ASF, holds 68.97% of the issued share capital of CMR, a private company that holds 87.5% interest in Dawson West coal project in Queensland.

The project has confirmed export quality thermal coal resources and has defined a JORC2012 code compliant resource totaling 876Mt (188Mt Indicated, 688Mt Inferred resource). In addition, the project has obtained approvals for a 1 million tonnes sample pit.
