## **Annual General Meeting Letter to CDI Holders**

Unibail-Rodamco-Westfield SE ("URW SE") hereby informs you that its annual general meeting will be held at Palais des Congrès de Paris, 2, place de la Porte Maillot, Salle Bordeaux, 75017 Paris, France on Tuesday 29 April 2025 at 10:30 a.m. (CET) (the "Meeting"), for the purpose of considering and voting on the resolutions contained in the URW SE Notice of Meeting available at <a href="https://www.investorvote.com.au">www.investorvote.com.au</a>. The Meeting comprises an ordinary general meeting and extraordinary general meeting.

You are being given this notice because you are the holder of CHESS Depositary Interests ("CDIs") in respect of Unibail-Rodamco-Westfield ("URW") stapled shares (each stapled share comprising one ordinary share in URW SE and one class A share in Unibail-Rodamco-Westfield N.V.).

Each person who is recorded as a CDI holder as at 7:00 p.m. (Australian Eastern Standard Time) on Wednesday 16 April 2025 (the "CDI Record Date") in the register of holders of CDIs kept by or on behalf of URW SE (each such person being a "Relevant CDI Holder") is entitled to instruct CHESS Depository Nominees Pty Limited ("CDN") or its custodian which holds the URW SE ordinary shares underlying their CDIs how to vote those shares on the resolutions to be considered at the Meeting. If you expect to be a Relevant CDI Holder and wish to give such voting instructions you must complete and submit the CDI voting instruction form available at www.investorvote.com.au.

Please note that you are not the registered holder of the URW SE ordinary shares to which those CDIs relate, and therefore are not entitled to vote in person at the Meeting of URW SE in your capacity as a holder of CDIs.

A CDI voting instruction form can be submitted:

- by mail by sending the CDI voting instruction form to URW SE's Australian CDI registry services provider, Computershare Investor Services Pty Limited ("Computershare") (GPO Box 242, Melbourne, Victoria 3001, Australia);
- 2) by faxing your CDI voting instruction form to Computershare: (within Australia) 1800 783 447 or (outside Australia) +61 3 9473 2555; or
- 3) by internet at www.investorvote.com.au.

For your CDI voting instruction form to be valid, it must be received by Computershare by no later than 5:00 p.m. (Australian Eastern Standard Time) on Wednesday 16 April 2025 in order to allow CDN orits custodian which holds the underlying URW SE ordinary shares sufficient time to provide voting instructions in respect of the relevant URW SE ordinary shares to URW SE by the proxy submission deadline on Saturday 26 April 2025, and in addition you must be a Relevant CDI Holder.



## How to give voting instructions to CDN or its custodian

Submit voting instructions in respect of the URW SE ordinary shares underlying your CDIs (being the CDIs of which you are the registered holder as at 7:00 p.m. (Australian Eastern Standard Time) on the CDI Record Date) that CDN or its custodian holds on your behalf by directing CDN or its custodian to cast votes at the Meeting, via a proxy or proxies appointed by CDN or its custodian, in the manner directed by you in the CDI voting instruction form. This is the "Standard Option (Voting Directions)" as shown on the CDI voting instruction form.

### Alternative option if you wish to attend and vote at the Meeting in person

Instead of simply giving voting instructions to CDN or its custodian, you can instruct CDN or its custodian to appoint yourself or another person as proxy of CDN or its custodian to attend and cast votes as proxy at the Meeting in person in respect of the URW SE ordinary shares underlying your CDIs (being the CDIs of which you are the registered holder as at 7:00 p.m. (Australian Eastern Standard Time) on the CDI Record Date. This is the "Alternative Option (Proxy Appointment)" as shown on the CDI voting instruction form. If you choose this option and you name a person other than yourself as a proxy, you should make your own arrangements if you wish for that person to vote in a certain way as URW SE will not supervise voting instructions given to a proxy (except that if the chairman of the Meeting is appointed as proxy the chairman is required to vote for (i.e. in favour of) all resolutions submitted or approved by the Management Board of URW SE).

IMPORTANT NOTE: Please only select the "Standard Option (Voting Directions)" or the "Alternative Option (Proxy Appointment)". Your form will not be valid and will not be taken into account if you select the "Alternative Option (Proxy Appointment)" but also give voting instructions pursuant to the "Standard Option (Voting Directions)".

URW has been granted Australian Securities Exchange ("ASX") waivers to allow URW to defer, and not to process, conversions between its stapled shares and CDI registers, during the period commencing on and including Monday 14 April 2025 and ending on and including Friday 25 April 2025 (being the voting entitlement record date for URW SE shareholders). This is intended to prevent the potential for votes to be cast twice in respect of the same parcel of URW SE ordinary shares, given that the CDI Record Date is earlier than the voting entitlement record date of Friday 25 April 2025 for URW SE shareholders.

As 20 CDIs collectively represent a beneficial interest in one URW SE ordinary shares (as part of a URW stapled share), a Relevant CDI Holder will be entitled to give a voting instruction in respect of one vote at the Meeting for every 20 CDIs held by such Relevant CDI Holder as at 7:00 p.m. (Australian Eastern Standard Time) on the CDI Record Date. There are no fractional entitlements to voting rights.
