## **Why have we made changes to the fund names?**

- Following the Australian Securities and Investments Commission's (ASIC) updates to the Information Sheet 230 *Exchange-traded products: Admission guidelines* on product labels and naming considerations, we've updated the name of all 17 SPDR ETFs listed on the ASX. As a result, our funds now include 'ETF' at the end of their name for easier identification and differentiation from other investment products.
- We've also made minor updates to the names of select sustainable investing ETFs to enhance investors recognition of each fund's key features. S&P Dow Jones Indices, the index provider to these funds, will also be changing the benchmark names to align with the new fund names.
