Brisbane, 28 April 2025: Health and Plant Protein Group Limited (ASX:HPP) (**HPP**, the **Company**) presents its Activities Report and Appendix 4C for the quarter ended 31 March 2025.

Business update

The Company ended the quarter with closing cash and cash equivalents of \$0.73 million (31 Dec 2024: \$0.90 million). Appendix 4C as attached forms part of this announcement. The amount of \$12,000 under item 6.1 relates to remuneration of non-executive directors.

As previously disclosed, HPP continues to work towards the repayment of the balance of the sale proceeds held by the US Internal Revenue Service (**IRS**) pending finalisation of the US withholding tax payable by HPP in respect of the sale of the macadamia division in April 2023.
