REPORT ON QUARTERLY ACTIVITIES TO ACCOMPANY APPENDIX 4C

Q3 FY25 – Operations

Net cash from operating activities in the third quarter was positive \$27,000 and for the 9 months to 31 March 2025 net cash from operating activities was positive \$295,000 (after inclusion of the one-off payment of \$500,000 following the insurance claim settlement in the first quarter).

Cash on hand at 31 March 2025

The Company had funds / interest bearing deposits on hand totalling \$8.044m.

Payments to related parties of the entity and their associates

The amount disclosed in item 6.1 in the accompanying Appendix 4C relates to the payment of directors' fees.

Corporate activities

The Company continues to evaluate acquisition prospects with the key focus in that process being to ensure that the continuing ownership requirements for the utilisation of tax losses can be met together with evidence of a profitable history with sustainable growth prospects to ensure the franking credits can be utilised.

ASX suspension

As previously advised to the market, SIV Capital Limited securities were suspended from quotation on 18 December 2024. ASX determined that SIV's operations were not adequate to warrant continued quotation of its securities and therefore the Company was in breach of Listing Rule 12.1. The suspension will continue until ASX can be satisfied that the Company is in compliance with the Listing Rules, including Listing Rules 12.1 and 12.3, and that it is otherwise appropriate for SIV's securities to be reinstated to quotation.

The Company will continue to release periodic disclosure to ensure the market is fully informed under Listing Rule 3.1-3.1B, while it remains suspended.
