

Growing ARR through new logos and customer expansion, plus tight costs management propels Beonic toward profitability

Q3 FY25 Highlights

- Recurring Revenue of \$4.4m (+6.4% vs PCP¹) and Annualised Recurring Revenue (ARR) of \$17.8m² (+6.5% vs PCP).
- Strong and sustained YTD gross margin of 75.5%, a notable improvement compared to the FY24 gross margin of 68.5%. Improved GM reflects our ongoing efforts to enhance profitability and progress towards cashflow breakeven.
- Cash flow from operations was negatively impacted by \$320k in non-recurring payments associated with cost-cutting measures. As a result, net cash outflow from operations was \$114k for Q3 FY25.
- Cash costs related to staff, administration and corporate continued to improve to \$2.7m (as detailed in the Appendix 4C). This reflects the positive impact of ongoing cost reduction initiatives.
- During the quarter, \$724k was collected related to the two-tranche placement that had been offered earlier in 2024 (refer to ASX releases from 19 June 2024 and 20 December 2024).
- Key contract wins this quarter include JFK International Airport (USA), Verizon (USA), Charlotte Douglas International Airport (USA), Rivian (USA), Adelaide Airport (APAC), Christchurch Airport (APAC) and Western Australia Museum (APAC).
- Notable renewals were also secured with, David Jones (APAC), Land Securities (UK), Narita International Airport (APAC) and Norwich Football Stadium (UK).
- Beonic has appointed Marc Thompson as Chief Technology Officer, effective 10 February 2025. Marc joins Beonic following
 a successful exit from his previous company, NewBook, where he served as CTO. Additionally, Michael Pearce was
 appointed as Company Secretary, in addition to his current role as Chief Financial Officer.
- Beonic, has announced a strategic agreement with e& UAE (formerly branded as Etisalat), the flagship telecommunications arm of global technology group e&, to introduce innovative WiFi analytics solutions into the UAE market. This partnership is set to dynamically reshape market conditions and redefine conventional approaches within the WiFi analytics sector.
- Beonic's Board of Directors and Executive Team conducted a thorough organisational review to enhance the company's
 ongoing efforts to optimise its cost structure. As a result, we have implemented measures that not only deliver additional cost
 savings but also reinforce our commitment to improving gross margins, achieving cash flow breakeven from operations and
 to maintain EBITDA profitability in FY25.

Outlook

- Maintain strong YoY gross margin improvement (75.5% YTD vs 68.5% FY24) while obtaining breakeven during Q4, FY25
- Currently forecasting cashflow breakeven from operating activities during Q4, FY25
- We anticipate a run rate EBITDA margin exiting FY25 of between 12% and 15%

 - o Solidify Beonic's position as a global leader in IoT solutions, specifically for Airports and Retail sectors
 - Achieve financial stability through disciplined cost management and operational efficiency
 - o Enhance product adoption by driving customer success initiatives and continued R&D investment
 - Deliver key projects with a focus on customer satisfaction and operational excellence, minimising customer churn and contraction
 - Secure new logos and maximise upsell opportunities to further strengthen the \$4.4m recurring revenue and \$17.8m
 ARR achieved this quarter
 - Accelerate pipeline conversion from the \$29.0m qualified deal pipeline, supported by targeted sales initiatives
 - Stay lean and maintain agility, ensuring a strong competitive advantage in the market

Commenting on the March 2025 Quarter, Beonic CEO, Billy Tucker said:



The sustained gross margin improvement to 75.5%, combined with our disciplined approach to cost management, as demonstrated by continued improvement in net cash flows from operations, reflects our ongoing commitment to financial stability and profitability. Our growing annual recurring revenue base to \$17.8 million, along with key contract wins with partners such as JFK, Charlotte Douglas International Airport, Verizon, and most recently e& UAE (formerly branded as Etisalat), underscores the strength of our global product offering and the value we deliver to

customers across multiple sectors.

Looking ahead, we remain focused on accelerating product adoption, converting our strong \$29.0 million deal pipeline, and consistently delivering exceptional outcomes for our customers. We look forward to sharing further key announcements through <u>Beoinic Investor Hub</u> and are committed to strengthening shareholder engagement as we continue to build momentum and drive sustainable, long-term growth."

Key contract wins during the quarter

Beonic secured renewals and new contract wins during the quarter including:

Notable new contract wins this quarter

- USA: Beonic extends its partnership with JFKIAT terminal 4 with the launch of our digital display product and mobility cart tracking solution. The Digital Display solution presents average wait times for mobility carts to assist departing and arriving passengers navigate the airside concourse.
- **USA:** In partnership with Verizon, Beonic secured a contract with Verizon to install Lidar at CHI Door manufacturing, integrating with 'Beonic Display' to monitor forklift movements and provide real-time updates. This enhances safety and operational efficiency.
- **USA:** Beonic secured a contract to expand its Queue Management System at Charlotte International Airport, adding a new checkpoint equipped with additional Lidar.
- USA: Beonic continues to extend its partnership with US headquartered Electric car manufacturer Rivian. Combining LiDAR and people counting technology, Beonic is measuring the walk-in performance of car dealerships.
- APAC: Beonic secured a contract with Adelaide Airport to expand its Passenger Flow Management System to International Arrivals and Departures, enhancing passenger experience and optimizing staffing.
- APAC: Beonic has been awarded an expansion of our Passenger Flow Management solution at Christchurch Airport. This follows the successful award of a teaming agreement with the Civil Aviation Authority New Zealand
- APAC: Beonic has been awarded a contract with Western Australian Museum to deploy our proprietary people counting solution for public venues.


Notable renewals this quarter

- APAC: Beonic has signed a new 3 year contract with Australian leading department store operator David Jones to maintain the footfall traffic solution.
- **UK:** Beonic secured a 2 year renewal with Land Securities for its Guest WiFi analytics solution, supporting CRM, loyalty programs, and guest WiFi management.
- APAC: In partnership with Hitachi, Beonic secured a further term with Narita International Airport in Japan for its passenger queue management system.
- **UK:** Beonic has extended its partnership with Norwich Football Stadium for a further term. The stadium has deployed its Guest WiFi analytics solution and guest WiFi management.



Net Cash Flow from Operating Activities

Q3 FY25 net cash outflow from operations of \$114k, including one-off costs associated with cost-cutting of \$320k. Cash outflow from operations was positively impacted by capitalizing \$661k of certain research and development costs incurred in accordance with AASB 138.



The Company had USD \$3.1m (~AUD \$4.9m) of debt facilities at 31 March 2025, as noted in Section 7 of the Appendix 4C.
