SenSen signs contract extension with Brisbane City Council

Coverage expanded with innovative new product - SenPIC

Brisbane City Council has been a customer of SenSen since 2017 and has continually increased its use of SenSen technology over time to manage the city kerb infrastructure. This latest contract includes existing mobile enforcement and a roll out of our latest groundbreaking innovation – SenPIC, our pole insertable fixed camera systems.

During the quarter, Brisbane City Council, expanded its enforcement coverage with an order for SenSen pole insertable cameras providing advanced kerb management and enforcement capabilities at multiple locations around the city. This is a significant milestone for our groundbreaking, award winning, innovation, SenPIC. Due to its cost effectiveness, ease of deployment and quality of data and evidence it generates, scaling kerb management operations is effective and simple. The contract covers the transition of all existing mobile hardware and software, currently in use across the city, to next generation solutions.

Based on current variable revenue run rates, over four years the contract is expected to generate around \$8.0M in revenue for SenSen. The contract is an extension to the existing agreement between SenSen and Brisbane City Council with terms of trade materially consistent with the existing agreement. The contract includes standard termination provisions. The contract extension is structured as an initial two-year commitment, with an option to extend for a further two years at the Brisbane City Council's discretion.

Commenting on the contract, SenSen CEO Dr Subhash Challa said:

"This is another great example of the long-term relationships we have been able to build with key cities globally. This extends a decade-long relationship with Brisbane City Council for an additional 4 years. Long term, value creating relationships with our clients are central to our strategy and its pleasing to see Brisbane City Council extending this relationship, as Calgary did in September 2024 to extend their partnership with SenSen for an additional 9 years".
