The Company has agreed, subject to obtaining shareholder approval, to issue Oakley Capital a total of 68,846,154 Shares and 82,115,385 RMLOC Options and pay Oakley Capital a capital raising fee of 6% of the gross proceeds of the placement for these services. The Company has also agreed to pay the vendors under the acquisition an aggregate cash payment of \$1,000,000. Further information in relation to the agreement with Oakley Capital and the acquisition agreement is set out in the ASX announcement released on 11 June 2025.
