Mr Taylor was Managing Director of Oklo Resources Limited when it was acquired by B2Gold Corp in September 2022 and was a Non-Executive Director of Chesser Resources prior to takeover by Fortuna Mining Corp in September 2023. He is currently Managing Director and Chief Executive Officer of Stellar Resources Limited.

Mr Taylor is a Member of the Australian Institute of Geoscientists (MAIG) and a graduate of Sydney University.
