The Wilson Asset Management Group <u>does not beneficially own, and exerts no control or influence over,</u> Benjamin Hornigold Limited (ASX: BHD) shares in which members of the Wilson Asset Management Group are determined to hold an indirect deemed relevant interest in, in accordance with Section 671B of the Corporations Act 2001. As detailed in the enclosed notice, members of the Wilson Asset Management Group are determined to hold an indirect deemed relevant interest in BHD shares held by Keybridge Capital Limited (KBC). The Corporations Act determine these indirect deemed relevant interests to exist primarily as a result of the members of the Wilson Asset Management Group holding (in aggregate) voting power in excess of 20% in KBC.

As a result of this indirect deemed relevant interest, and in accordance with Section 671B of the Corporations Act 2001, please find enclosed a Form 604 - Notice of change of interest of substantial holder in relation to Benjamin Hornigold Limited (ASX: BHD). The Corporations Act requires the Wilson Asset Management Group to submit this form on the ASX despite the Wilson Asset Management Group not holding any direct shares in BHD. The primary purpose of this notice is to disclose certain indirect deemed relevant interests that members of the Wilson Asset Management Group are indirectly deemed to hold in BHD pursuant to the Corporations Act.

On 10 February 2025, Mr Geoffrey Wilson AO, Mr Jesse Hamilton and Mr Martyn McCathie of Wilson Asset Management Group were appointed as KBC directors and are three of the five current KBC directors. Members of the Wilson Asset Management Group are not able to affect the direction or control of BHD and have no influence or control over BHD's underlying investments. 
