

## ASX ANNOUNCEMENT

### Update - Second Meeting of Creditors

I refer to the appointment of Kathryn Evans, Kate Warwick, David McGrath and I, Vaughan Strawbridge, as Joint and Several Administrators of Mosaic Brands Limited (ASX:MOZ) and the companies in the Schedule A ("the Companies") on 28 October 2024 pursuant to section 436A of the *Corporations Act 2001 (Cth)* ("the Act").

On Friday 20 June 2025 the Administrators opened the concurrent second meeting of creditors of the Companies ("Second Meeting") to decide the future of the Companies.

As at Friday 20 June 2025, no Deed of Company Arrangement in relation to the Companies has been received by the Administrators of the Companies.

The Second Meeting was adjourned for a period of up to fifteen (15) days.
