PERFORMANCE AND COMPANY UPDATE

As at 31 May 2025, the Company's investments delivered a total return of 10.3% p.a.¹ (after fees) and distributed a yield of 7.6% p.a. (incl. franking) since inception² compared to the S&P/ASX 200 Franking Credit Adjusted Daily Total Return Index (Tax-Exempt) ('Benchmark') return of 10.1% p.a.¹ and a yield of 5.3% p.a.¹.

MONTHLY DIVIDENDS

During the month of April, the Board of Plato Income Maximiser Limited (ASX: PL8) resolved to pay three fully-franked dividends of \$0.0055 per share payable in April, May and June 2025, which is a continuation of the level of dividends paid during the March 2025 quarter.

MARKET OVERVIEW

Australian equities extended their recovery in May, rebounding from the earlier April decline triggered by geopolitical tensions surrounding U.S. trade policy. Market sentiment improved notably following President Trump's decision to significantly scale back proposed tariffs on China—from 145% to 30%—a move that investors have dubbed the "TACO" trade (Trump Always Chickens Out). Meanwhile, the Reserve Bank of Australia reduced interest rates by 25 basis points and signalled that it had considered a 50 basis point cut, prompting bond markets to price in an additional easing in July. Given Australia's limited direct exposure to the tariffs, we believe this policy shift could support domestic economic growth by boosting consumer spending. The technology sector led performance with a 20% gain, driven by renewed enthusiasm around AI and strong updates from Life 360 and Technology One. Gold stocks also delivered strong returns, while defensive sectors such as Utilities, Consumer Staples, and Healthcare lagged, posting only modest gains.

Some of the largest positive contributors to the Company's performance during the month were overweight positions in Qantas, Technology One, Pro Medicus and Orica as well as an underweight position in CSL. However, overweight positions in Aristocrat Leisure, ALS Ltd and AP Eagers as well as underweight positions in Wisetech and Life 360 detracted from relative performance.

The Company remains actively positioned to seek superior income than the benchmark.

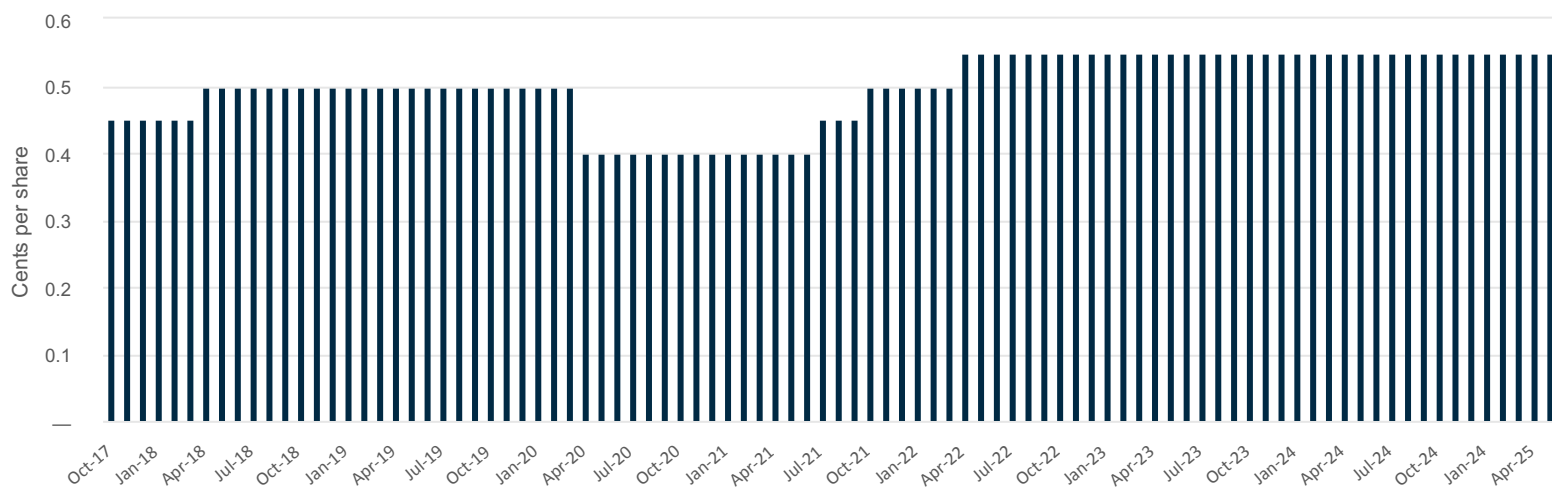

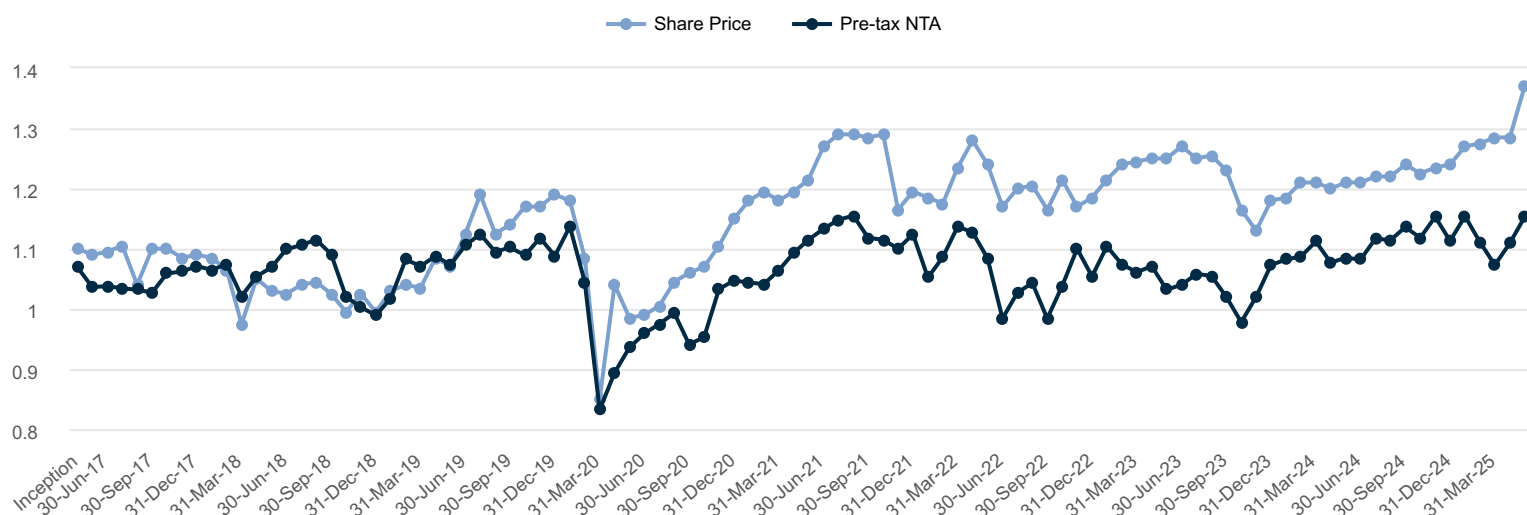
