PLACEMENT TO RAISE \$427,200

Ragusa Minerals Limited (ASX: RAS) ("Ragusa" or "Company") would like to advise that it has received firm commitments from sophisticated investors to raise up to \$427,200 (before costs) at \$0.012 per share, representing a 14.4% discount to the Company's 15 day Volume Weighted Average Price ("VWAP") as of 26 June 2025.

Placement terms:

- Placement of up to 35,600,000 fully paid ordinary shares under its existing placement capacities available under ASX Listing Rule 7.1 and 7.1A at 1.2 cents (\$0.012) per share to sophisticated and professional investors to raise \$427,200.
- Subject to shareholder approval to be sought at a general meeting of the Company to be held as soon as practicable, for every three (3) Shares issued under the Placement investors will receive one (1) free attaching option, each with an exercise price of three cents (\$0.03) expiring three (3) years from the date of issue.

Settlement is expected to occur by 4 July 2025.

Funds raised from the Placement will enable Ragusa to assess potential new project acquisitions and for corporate and general working capital requirements.
