CLEANSING NOTICE – ISSUE OF SHARES

Rapid Critical Metals Limited (**'Rapid,' 'RCM' or 'Company'**) advises that the Company today issued a total of 416,666,667 ordinary shares on a post consolidation basis at an issue price of \$0.024 each (**Shares**), pursuant to the placement announced to ASX on 26 June, 2025 and approved by shareholders at the Extraordinary General Meeting held on 7 July, 2025.
