

RESULTS OF 2025 GENERAL MEETING

Resolution Minerals Ltd (ASX: **RML**) (**Resolution** or the **Company**) advises, in accordance with ASX Listing Rule 3.13.2 and section 251AA(2) of the *Corporations Act 2001* (Cth), in regards to the General Meeting which was held today, Friday 25 July. Details of the outcome in respect of each resolution and numbers of valid proxy votes as detailed in the table below. All resolutions were passed on a poll.

Horse Heaven Acquisition Update

The Company is pleased to announce that it has received shareholder approval for the acquisition of the Horse Heaven Antimony-Tungsten-Gold-Silver project (as originally announced to the ASX on 11 June 2025).

All the key steps to completion of the acquisition have been satisfied, and the Company confirms that it has completed due diligence on the project and the vendors to its satisfaction.

Additionally, a resolution with respect to this acquisition was passed this morning at the general meeting, demonstrating strong support from shareholders for this transaction.

The Board looks forward to continuing to update shareholders as the Horse Heaven project continues to mature and develop into one of the few Antimony projects in the USA that has the potential to meet the national security interests of the U.S. and the Trump Administration's policy.

Completion of the acquisition is due to occur early next week.
