### CORPORATE

Icon Energy Limited at the end of the quarter held a cash and bank balance of \$431,414.

#### Payments to related parties of the entity and their associates:

#### Exploration activities:

There were no exploration activities during the quarter.

#### Notice of Proposed Grant of a Petroleum Lease PL-1144:

The Department of Resources (DOR) sent Icon Energy a Notification to Grant a Petroleum Lease PL-1144 on 26th January 2025. This Notification called for a revision of the Right to Negotiate (RTN). Icon is currently waiting for the DOR to grant the final documentation. Once received, the Company will recommence negotiations with several Interested parties through a farmin offer to join Icon as a Joint Venture Partner in the Lease which is outlined the Initial Development Plan (IDP). This plan was lodged with the DOR on 30 August 2024.

A market announcement will be released upon receipt of the final documentation from the DOR.
