Brickworks Limited (**Brickworks** or **BKW**) (ASX:BKW), refers to its announcements released to the ASX on 1 August 2025 and 4 August 2025 regarding the BKW Share Scheme Meeting (as defined in those announcements). You will have received, or will shortly receive, materials in relation to the BKW Share Scheme Meeting.

You are hereby receiving additional materials in relation to a separately announced general meeting which will be held on Wednesday, 10 September 2025 at 9.00 am (Sydney time), to be adjourned until immediately following the conclusion of the BKW Share Scheme Meeting, at The Grand Ballroom, The Fullerton Hotel, 1 Martin Place, Sydney NSW 2000 (**General Meeting**). An announcement regarding the General Meeting was made on 5 August 2025.

The BKW Share Scheme Meeting and General Meeting are distinct in purpose, with shareholders required to vote separately for each meeting.

1. **BKW Share Scheme Meeting** – this relates to the proposed Combination of Brickworks and Washington H. Soul Pattinson and Company Limited, under a new holding company, First Services Company Ltd (ACN 687 534 023) (**Topco**). You would have received key information and supporting documents (based on your communication preferences) separately. It includes:
 - (a) a Combination Booklet, with the Notice of BKW Share Scheme Meeting and explanatory notes appended; and
 - (b) a personalised **WHITE** Proxy Form for voting on the BKW Share Scheme.
2. **General Meeting** – this relates to the resolution for the grant of the FY26 long term incentive (**FY26 LTI**) to the proposed Managing Director and CEO of Topco (**Resolution**).

Appended with this letter is:

- (a) a Notice of General Meeting with detailed explanatory notes; and
- (b) a personalised **GREEN** Proxy Form for voting on the General Meeting.

Accordingly, **your vote is required separately for each meeting** and you will need to return both proxy forms if you wish to vote by proxy, on or before the designated cut off times set out in each relevant Notice of Meeting.

You are encouraged to read through these documents in their entirety, seek independent advice if required, and have your say.
