**Etherstack signs record deal with US giant AT&T**

Following on from our previous announcements dated 22 January 2025 and 11 April 2025, Etherstack is pleased to announce that Etherstack's US subsidiary Etherstack Inc. has entered into a Master Supply Agreement ("MSA") with AT&T Services Inc. for the provision of Etherstack's telecommunications solutions and services related to Mission Critical Push-to-Talk ("MCPTT") technologies, notably Etherstack's LMR-IWF ("InterWorking Function") product and other associated elements and services. The "Initial Term" of the MSA is 7 years, with further extensions available subject to adequate performance.

During the Initial Term, and subsequent terms when contracted, Etherstack will receive a minimum of US\$2.5m per annum (indexed) in support and service fees. From FY2026 variable revenues based on subscriber volume and professional services requests will also be earned in addition to the support and service fees. These variable revenues cannot be quantified at this time. This contract is subject to the normal terms and conditions associated with a contract of this nature.

During FY2025 (ending 31<sup>st</sup> December 2025), Etherstack management expects the contract to contribute approximately US\$4m to the current year's revenues, of which US\$2.37m has been previously disclosed to the market in the first half ending 30<sup>th</sup> June, 2025.
