### FY2025 – PRELIMINARY FINAL RESULTS, FINANCIAL STATEMENTS & DIVIDEND

Acumentis Group Limited (ASX: ACU) (**Acumentis**) is pleased to release its financial results for the year ended 30 June 2025 and to announce the declaration of a FY2025 dividend.

#### Highlights

- FY2025 Dividend of 0.22 cents per share declared
- Operating revenues increased 4% vs prior year
- Operating profits increased 35% vs prior year
- PBT increased 13% vs prior year

Acumentis has delivered an improved financial performance for the year ended 30 June 2025 with increased operating revenues and profits.

The Board of Acumentis has declared a dividend of 0.22 cents per share in respect of the year ended 30 June 2025.

#### FY2025 DIVIDEND
