About this notice

This notice (**Notice**) is issued by Global X Management (AUS) Limited (**Global X**) as the Responsible Entity of each of the funds listed in **Table 1** (each a **Fund** and together **Funds**).

This Notice provides prior notice of at least 30 days and contains important information about certain changes to the fees and costs which will apply to each Fund.

Please note: There is no change to the Management Fees for each Fund.

On or about 22 September 2025, we expect to update the Product Disclosure Statement (**PDS**) of each Fund, including to reflect certain changes to fees and costs which will take effect on or after that date.

Except for certain 'in-specie' redemptions from the EETH, EBTC and GXLD Funds, these increased fees and charges apply only to contributions and withdrawals made by Authorised Participants (as defined in each PDS).

For the avoidance of doubt, the fees in Table 1 **do not apply** to the buying and selling of units in the Funds on the exchange.

This notice also constitutes a continuous disclosure notice for the purposes of section 675 of the Corporations Act for each Fund. This Notice is not a supplementary product disclosure statement for the purposes of the *Corporations Act 2001*.

Changes to fees and costs

Effective on or about 22 September 2025, by this Notice and the updated PDSs, Global X will be increasing the contribution and withdrawal fees for each of the Funds. These fees may be waived in whole or in part subject to the discretion of the Responsible Entity, where permitted to do so.

Details of these changes are set out in Table 1 below.
