DEED OF COMPANY ARRANGEMENT EFFECTUATED 26 JUNE 2025

Epsilon Healthcare Limited (ASX: EPN) is pleased to announce that the Deed of Company Arrangement executed 24 June 2024 (**DOCA**), was wholly effectuated by its terms under s445C(c) on 26 June 2025. Participating creditors' claims have been extinguished under the DOCA, and the Company is no longer subject to the DOCA.

The effectuation of the Epsilon Healthcare DOCA as mentioned in the CEO & MD Update on 27 June 2025, follows an announcement by the Company on 20 February 2025, announcing of the effectuation of the Epsilon Clinics Pty Ltd DOCA on 19 February 2025, in addition to an announcement on 3 April 2025 of the effectuation of the Epsilon Pharma Pty Ltd DOCA, effective from 2 April 2025.

Epsilon CEO & Managing Director, Peter Giannopoulos commented:

"We are extremely pleased & proud to advise that the parent entity and all subsidiaries have now officially exited voluntary administration and all deeds of administration following the successful completion of all obligations under their respective Deeds of Company Arrangement (DOCAs). The deed administrators have confirmed that all conditions precedent and requirements under the DOCAs have been fully satisfied.

This marks a significant milestone for the company and reflects the positive outcome of the restructuring & relaunch process. The company looks forward to putting this unfortunate event behind it whilst committing to ensuring that those responsible for putting the company through this unnecessary turmoil are held to account.

The Company acknowledges the support of clients, stakeholders, and team members throughout this period and is now well positioned to focus on rebuilding shareholder value and pursuing its strategic & operational objectives".

The Company will provide a further market update in due course regarding its operational and financial outlook.
