Deferred Rights will vest on 30 June 2028, subject to (1) the participant, remaining continuously employed or otherwise not being considered an 'Adverse Leaver' under the Deferred Remuneration Plan Rules; and (2) the Company achieving a specific profit margin hurdle for the period 1 July 2025 to 30 June 2028. Each Deferred Right constitutes a right to receive one (1) PTM ordinary share. Prior to the Deferred Rights being exercised, there is no entitlement to vote and receive dividends.

Each Deferred Right carries an entitlement to a dividend equivalent payment. In summary, upon the valid exercise, or deemed exercise, of a Deferred Right, a participant will also be entitled to receive an amount approximately equal to the amount of dividends that would have been paid to them had they held the PTM ordinary share issued, transferred or allocated to them on the exercise of that Deferred Right, from the grant date.
