Results of SOL Share Scheme Meeting and BKW Share Scheme Meeting and results of SOL General Meeting and BKW General Meeting

Washington H. Soul Pattinson and Company Limited ("**Soul Patts**" or "**SOL**") (ASX: SOL) and Brickworks Limited ("**Brickworks**" or "**BKW**") (ASX: BKW) are pleased to announce that:

- at the SOL Share Scheme Meeting today, SOL Shareholders voted in favour of the SOL Share Scheme; and
- at the BKW Share Scheme Meeting today, BKW Shareholders voted in favour of the BKW Share Scheme,

(together, the "**Share Schemes**") to give effect to the proposed combination of Soul Patts and Brickworks.¹

Results of the SOL Share Scheme Meeting and BKW Share Scheme Meeting

In accordance with ASX Listing Rule 3.13.2 and section 251AA(2) of the *Corporations Act* 2001 (Cth) (Corporations Act), Soul Patts and Brickworks advise that the respective resolutions to approve the SOL Share Scheme and the BKW Share Scheme (the "SOL Share Scheme Resolution" and the "BKW Share Scheme Resolution" respectively) were passed today by the relevant Required Majorities.

In summary:

SOL Share Scheme Resolution

- 96.84% of SOL Shareholders present and voting at the SOL Share Scheme Meeting (in person, or by proxy, attorney or corporate representative) were in favour of the SOL Share Scheme Resolution; and
- 92.42% of the total number of votes cast by SOL Shareholders at the SOL Share Scheme Meeting were in favour of the SOL Share Scheme Resolution.

BKW Share Scheme Resolution

 97.40% of BKW Shareholders present and voting at the BKW Share Scheme Meeting (in person, or by proxy, attorney or corporate representative) were in favour of the BKW Share Scheme Resolution; and

• 98.81% of the total number of votes cast by BKW Shareholders at the BKW Share Scheme Meeting were in favour of the BKW Share Scheme Resolution.

Results of SOL General Meeting and BKW General Meeting

Further to the respective announcements released to the ASX by Soul Patts and Brickworks on 5 August 2025 in relation to their respective General Meetings to approve the grant of FY26 long term incentives to the proposed Managing Director and CEO of Topco (respectively, "SOL General Meeting" and "BKW General Meeting"), and in accordance with ASX Listing Rule 3.13.2 and section 251AA(2) of the Corporations Act, Soul Patts and Brickworks each advise that the total number of proxy votes received and the voting results of the polls at the SOL General Meeting and the BKW General Meeting are set out in Annexure C and Annexure D to this announcement respectively.

Soul Patts and Brickworks each confirm that voting on the respective resolutions at the SOL General Meeting and BKW General Meeting was by way of a poll.

Next steps

The Share Schemes each remain subject to the approval of the Court at the respective hearings scheduled for 9:15am (Sydney time) on 12 September 2025 ("**Second Court Hearings**"), and certain other conditions precedent described in the respective SOL Combination Booklet and BKW Combination Booklet.

If the outstanding conditions precedent are satisfied or waived (as applicable) prior to the Second Court Hearings and the Court approves the Share Schemes, Soul Patts and Brickworks each propose to lodge office copies of their respective orders of the Court with the Australian Securities and Investments Commission ("ASIC") (which is expected to occur on 15 September 2025), at which time the BKW Share Scheme and the SOL Share Scheme will each become legally effective.

Following the lodgement of the respective Court orders with ASIC, it is expected that:

- from the close of trading on 15 September 2025, SOL Shares and BKW Shares will be suspended from trading on the ASX, following which Topco Shares will commence trading on a deferred settlement basis from Tuesday 16 September 2025² and on a normal settlement basis from Wednesday 24 September 2025³;
- on 22 September 2025, the SOL Shareholders and BKW Shareholders who are on the share registers of Soul Patts and Brickworks (respectively) at 7:00pm (Sydney time) on 17 September 2025 (being the record date) will receive:
 - for SOL Shareholders, 1 Topco Share for each SOL Share held on the record date;
 and

- o for BKW Shareholders, 0.82 Topco Shares for each BKW Share held on the record date; and
- on 23 September 2025, the Share Schemes will be implemented.
