Notice under section 708A of the Corporations Act

Dateline Resources Limited ACN 149 105 653 (ASX: DTR) (**Company**) hereby advises that a total of 8,000,000 fully paid ordinary shares in the Company (each, a **Share**) were issued by the Company to a sophisticated and professional investor on 17 September 2025 to complete the acquisition of the Argos Strontium Project.

 - A. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - B. the rights and liabilities attaching to the Shares and options.
