The weekly estimated unaudited pre tax net asset value before withholding tax on unpaid distributions as at 4 November 2016 was \$1.87\* per unit.

If estimated tax at 35% on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value before withholding tax on unpaid distributions as at 4 November 2016 would be \$1.65\* per unit.
