**Reef Casino Trust (ASX: RCT) – Notice of Initial Substantial Holder**

We act for Novomatic AG (**Novomatic**).

**Attached** is a Form 603 Notice of Initial Substantial Holder in relation to the Reef Casino Trust ARSN 093 156 293 (**Reef Casino Trust**) lodged on behalf of Novomatic.

As investors in the Reef Casino Trust are aware, Casinos Austria AG and its associated entities (**CASAG**) currently have a relevant interest in approximately 67.1% of the units on issue in the Reef Casino Trust, comprising 33,046,908 ordinary units and 370,000 founders units.<sup>1</sup>

As a result of a proposed upstream offshore restructure of the existing ownership of **CASAG (Proposed Restructure)** which, if implemented, would result in Novomatic and its proposed joint venture partner, Sazka Group a.s. (**Sazka Group**) acquiring (directly and indirectly) a majority interest in CASAG, Novomatic is presently deemed to have the same relevant interest in the Reef Casino Trust as CASAG currently has (that is, a relevant interest in approximately 67.1% of the units on issue).

Investors should note, however, that:

- as at the date of this letter, no stage of the Proposed Restructure has completed, such that Novomatic does not currently have any direct holding in CASAG and correspondingly is not in a position to control the exercise of any voting rights attached to units in the Reef Casino Trust or the disposal of units in the Reef Casino Trust;
- completion of the Proposed Restructure (which will occur in jurisdictions outside of Australia) remains subject to the satisfaction of various conditions precedent which are beyond the control of Novomatic, Sazka Group and CASAG, including several consents and approvals of various competition and gaming regulators internationally;

- \* the Austrian Cartel Court has made a determination that the Proposed Restructure not proceed in its current form, however this determination is subject to an appeal process the outcome of which is not expected to be known until December 2016 or January 2017; and
- \* no aspect of the Proposed Restructure will result in Novomatic acquiring a direct holding of units in the Reef Casino Trust.

Accordingly, there is no certainty that the Proposed Restructure (or any part thereof) will be implemented as envisaged. One aspect of the Proposed Restructure which is not subject to the approval of the Austrian Cartel Court (being a proposed acquisition by Novomatic of a direct 17.2% interest in CASAG) is intended to complete by the end of calendar year 2016 (subject to the satisfaction of all relevant conditions and approvals, including the approval of CASAG shareholders the vote in respect of which is expected to occur by the end of calendar year 2016).

Investors should also note that if the Proposed Restructure does not proceed as envisaged, Novomatic will likely cease to be deemed to have a relevant interest in the Reef Casino Trust, in which case it will notify the Reef Casino Trust and the market accordingly.

### Details of Relevant Interests

By virtue of the applications of sections 608(3) and 608(8) of the Corporations Act 2001 (Cth), Novomatic AG ("Novomatic") is deemed to have acquired the same relevant interest in the Reef Casino Trust ARSN 093 156 293 ("Reef Casino Trust") as that currently held by Casinos Austria AG and its associated entities ("CASAG").

CASAG currently has a relevant interest in 33,046,908 Ordinary Units and 370,000 Founders Units – refer to the Form 604 (Notice of change of interest of substantial holder) dated 4 July 2012 lodged by CASAG.

This relevant interest arises as a consequence of a proposed conditional restructure of the existing ownership of CASAG which, if completed, would result in Novomatic and its proposed joint venture partner, Sazka Group a.s. ("Sazka Group") acquiring (directly and indirectly) a majority interest in CASAG ("Proposed Restructure").

Completion of the Proposed Restructure has not yet occurred, and is subject to the satisfaction of a number of conditions precedent, which are beyond the control of Novomatic, Sazka Group and CASAG, including numerous consents and approvals of various competition and gaming regulators internationally.

No consideration has yet been paid by Novomatic in respect of the Proposed Restructure or to acquire a relevant interest in the Reef Casino Trust.
