Results of 2016 Annual General Meeting of Kimberley Diamonds Ltd

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Kimberley Diamonds Ltd advises the outcome of the resolutions put to shareholders at the Annual General Meeting on 24 November 2016 and the proxies received in respect of the resolutions put to shareholders in the attached summary.

Each resolution was decided on a poll.

All resolutions were passed:

- (a) Resolution 1: Adoption of Remuneration Report (non-binding) (passed by 99.23% of votes cast);
- (b) Resolution 2: Re-election of Director Alexandre Alexander (passed by 89.56% of votes cast);
- (c) Resolution 3: Re-election of Director Rupert Baring (passed by 89.64% of votes cast);
- (d) Resolution 4: Approval of a 10% placement facility (passed by 89.38% of votes cast); and
- (e) Resolution 5: Appointment of auditor (passed by 90.05% of votes cast).

Resolution 6 was a contingent resolution which was not required to be put to shareholders.
