- 5,798 performance shares (EVTAW) issued under the EVENT Hospitality & Entertainment Limited (“EVENT”) Performance Share Plan (the “Performance Share Plan”) have been transferred into ordinary shares (EVT) on the achievement of the Performance Share Plan’s hurdles and submission of a Notice of Withdrawal Form by, or termination of, various Performance Share Plan participants; and
- 611,269 performance shares (EVTAW) have been transferred into ordinary shares (EVT) in relation to the EVENT Performance Rights Plan (the “Performance Rights Plan”) on the achievement of the Performance Rights Plan’s hurdles. These performance shares (EVTAW) were originally issued under the Performance Share Plan and were subsequently forfeited due to certain hurdles not being met and the termination of certain Performance Share Plan participants.
