Investment Portfolio Performance to 30th November 2016 & Market Insight

The month of November proved again to be an eventful month with plenty of company specific updates with Annual General Meeting season in full flight. Unfortunately, the smaller industrials significantly underperformed the ASX-100 industrial index by -4.3% with a number of notable small industrials underwhelming the market. These included CSG Group (ASX: CSV) -45%, Adairs (ASX: ADH) -35% and iSentia (ASX: ISD) -28% for the month.

The notable events for the NCC Portfolio within the month came from Enero Group (ASX: EGG), Armidale Investments (ASX: AIK) and BSA Limited (ASX: BSA). Enero Group provided the market with updated guidance earlier in the month, which showed a sharp decline in margins within their UK operations, mainly due to the weakening of the British Pound, coupled with a drop in business activity due to the uncertainty around Brexit. To make matters worse EGG announced later in the month that Virgin Atlantic would be bringing some work in-house as a cost cutting initiative. The NAOS investment thesis post the above remains unchanged, albeit this financial year may well be two steps forward and one step back. We believe EGG can leverage their four main brands to continue to grow, and that it remains a strong net cash business with excellent cash flow generation. It is also worth highlighting the recent acquisition by US firm Accenture of leading UK independent creative agency group Karmarama for £50 million which has 250 staff compared to EGG's ~550 staff.

AlK announced to the market that they will be moving away from releasing Net Tangible Asset (NTA) valuations and instead release a set of consolidated financials. This is a very significant event as it will show the true underlying earnings power of the lease book and broking businesses and allow the company to be valued on an earnings multiple.

Finally, at the end of the month BSA made the long awaited announcement that all outstanding liabilities in regards to legacy contract works associated with the Royal Adelaide Hospital build had been settled with the head contractor. This removes a large cloud of uncertainty that has been hanging over BSA for almost 2 years. From an investment standpoint, it removes any potential liability and allows the current management team to focus on growing the revenue and earnings base of the business through exposure to an increasing industry spend in telecommunications services.

Positive Stock Attribution Analysis (Attribution is what has contributed to NCC's performance since inception) (1st March 2013 to 30th November 2016)

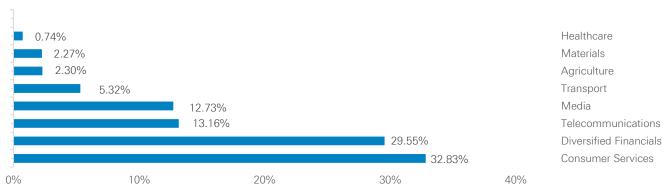

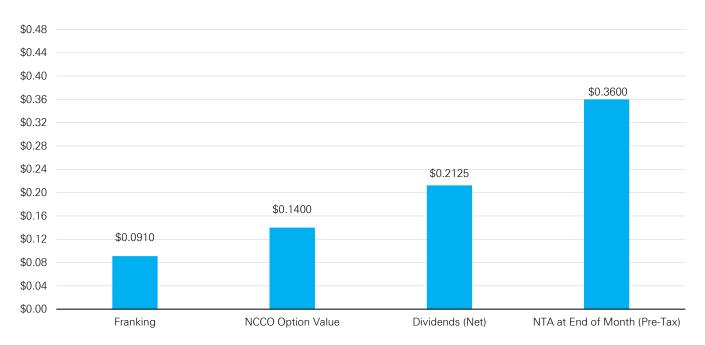

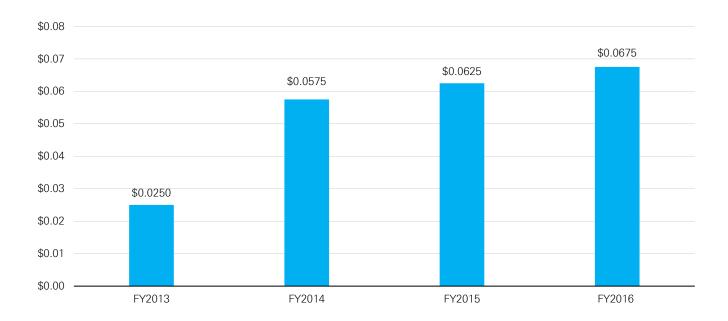

A Description of Statistical Terms/Glossary

Portfolio Average Market Capitalisation – The portfolio weight of each individual position multiplied by each company's respective market capitalisation.

Standard Deviation of Returns - A historical analysis of the volatility in monthly returns also known as historical volatility.

Correlation of Returns – A statistical measure of how two variables move in relation to each other. In this case the two variables are NCC and XSOAI, If the correlation is 1 then the two securities should have the same monthly returns and if the correlation is -1 and XSOAI had a return of -1.00% then NCC would be expected to have a return of +1.00%

Sortino Ratio - A modification of the Sharpe ratio that differentiates harmful volatility from general volatility by taking into account the standard deviation of negative asset returns, called downside deviation. A large Sortino Ratio may potentially indicate that there is a low probability of a large capital loss. Returns less than that of the benchmark (Small Ordinaries Accumulation Index - XSOAI) are classified as negative asset returns.

Downside Deviation - A measure of downside risk that focuses on returns that fall below a minimum threshold or minimum acceptable return (MAR). For our calculations, we use returns negative to zero for the calculation of portfolio downside deviation.

Portfolio Beta - A measure of the volatility, or systematic risk of a portfolio or security. A beta of 1 indicates a portfolio/security's price will move with the market. A beta of less than 1 indicated that a security/portfolio should be less volatile than the market.

XSOAI - Small Ordinaries Accumulation Index
