SUPERLOOP ENHANCES ITS BOARD AND SUB-COMMITTEES

Superloop Limited (ASX: SLC) (Superloop or Company) is pleased to announce that as a result of the implementation of the Scheme of Arrangement for the acquisition of BigAir Group Ltd (BigAir), it has enhanced the composition of its Board and sub-committees.

Mr Jason Ashton, appointed to the Superloop Board as an executive director, co-founded BigAir in 2002 and has been its Chief Executive Officer since 2006. He brings more than 23 years' telecommunications industry experience and was a pioneer within the Internet industry as Managing Director of business ISP Magna Data which he co-founded in 1993. He is a subject matter expert on fixed wireless broadband access networks and will continue to lead the BigAir business following the implementation of the Scheme of Arrangement.

Mr Vivian Stewart, appointed to the Superloop Board as an independent non-executive director, served on the BigAir Board from June 2008 and was its most recent Chairman. Mr Stewart has extensive background in the IT&T industry, venture capital and corporate advisory services. He cofounded two IT&T companies and is the founder & Managing Director of Callafin, an independent corporate advisory firm specialising in sale, merger and acquisition transactions and related capital strategy. He will serve on the Superloop Board's Audit and Risk Committee and Remuneration and Nomination Committee.

With the appointment of Mr Stewart, Mr Bevan Slattery, Superloop's Executive Chairman and Chief Executive Officer, has stepped down as a member of the Remuneration and Nomination Committee. Both the Audit and Risk Committee and Remuneration and Nomination Committee now consist entirely of non-executive independent directors, ensuring they meet the ASX Corporate Governance Council Principles and Recommendations.

In March 2017, Mr Matthew Hollis will take up the position of Group GM Sales and Marketing and will be appointed to the Board as an executive director. Mr Hollis is currently the Director of Corporate & Wholesale at Vocus Communications where he has worked for over 6 years. Prior to joining Vocus, Matt served in various sales and corporate roles with Pipe Networks and other ISPs and System Integrators.
