GENEX SIGNS EPC & O&M CONTRACT WITH UGL FOR THE 50MW KIDSTON SOLAR PROJECT

- Full wrap turn key contract signed with UGL as EPC & O&M contractor

Genex Power Limited (ASX: GNX, Genex or Company) is pleased to announce that it has signed an Engineering, Procurement and Construction (EPC) and Operation and Maintenance (O&M) contract with UGL Limited (ASX: UGL, UGL) for its 50MW Kidston Solar Project (Project) in Northern Queensland.

UGL will undertake the EPC, testing and commissioning of the Project, including the associated substation and Ergon Energy grid connection. Once construction of the Project is completed, UGL will undertake operations and maintenance of the solar farm for an initial period of 5 years, with a Genex option to extend for a further 5 years.

UGL CEO, Ross Taylor said: "UGL's end to end capabilities and technical expertise in linking generation assets to the electricity grid are strong market differentiators and combined with our growing track record in the design and delivery of solar farms, have been instrumental in securing this important opportunity with Genex for the delivery of the Kidston Solar Project."

Executive Director Simon Kidston stated, "This important milestone follows the execution of the Solar 150 Support Deed with the Queensland Government and the ARENA Funding Agreement, both of which have been integral to the successful development of the project and the commencement of the construction."

The Kidston Solar Project is a key component in ARENA's push to triple Australia's large-scale solar capacity by supporting 12 new solar farms. ARENA's unprecedented investment in large-scale solar is expected to unlock almost \$1 billion in commercial investment that will mostly be spent in regional Australian economies.
