On 30 April 2015, the Company announced that it had entered into an agreement with its largest shareholder ("Lender") for a \$300,000 secured convertible debt facility ("Facility").

On 1 March 2016, the Lender agreed to extend the term of the Facility by 18 months from 4 November 2016. The Facility maturity date is now 3 May 2018, in respect of the \$135,000 outstanding balance. The interest rate continues at 7% p.a and the debt is convertible at the lenders discretion at a 15% discount % to 5 day VWAP.

Further information regarding the Facility terms and conditions is detailed in the Company's Annual Report – 30 June 2016 (ASX Release 29 September 2016).
