A dividend of USD 0.33 per share was declared for holders of ResMed's common stock trading on the New York Stock Exchange. Holders of Chess Depositary Instruments (CDIs) trading on the Australian Securities Exchange will receive an equivalent amount in AUD, based on the exchange rate on the record date, and reflecting the 10:1 ratio between CDIs and NYSE shares.
