## RE: REQUEST FOR TRADING HALT – XPED LIMITED

Pursuant with Listing Rule 17.1, Xped Limited (**Xped** or the **Company**) (ASX Code: XPE) requests an immediate trading halt be granted by the ASX, with respect to its securities.

In accordance with Listing Rule 17.1, Xped advises:

- a) the reason for the request is to facilitate an orderly market in the Company's securities pending an announcement in relation to a proposed capital raising by the Company, by way of a placement to sophisticated and professional investors and a share purchase plan to eligible shareholders;
- b) Xped requests that the trading halt end on the earlier of:
  - (1) such time as it makes an announcement to the market about the results of the proposed placement and details of the proposed share purchase plan; and
  - (2) the commencement of normal trading on Wednesday 9 November 2016; and
- c) Xped is not aware of any reason why the trading halt should not be granted, or of any other information necessary to inform the market about the trading halt.
