## Request under Listing Rule 17.2 for voluntary suspension – Xped Limited

Xped Limited (**Xped** or the **Company**) (ASX Code: XPE) refers to the trading halt granted by ASX on Monday, 7 November 2016 until the commencement of normal trading on Wednesday 9 November 2016.

The trading halt was requested to enable the Company to manage its continuous disclosure obligations pending finalisation and announcement of a proposed capital raising.

The Company requests a voluntary suspension of its shares from ASX while it seeks to finalise the proposed capital raising.

In accordance with LR 17.2 the Company provides the following information:

- (a) the reason for the voluntary suspension is for the Company to manage its continuous disclosure obligations whilst finalising the proposed capital raising;
- (b) the Company requests a voluntary suspension until the earlier of;
  - (1) such time as it makes an announcement to the market about the results of the proposed capital raising; and
  - (2) the commencement of normal trading on Wednesday 16 November 2016; and
- (c) the event which will end the voluntary suspension is the announcement referred to in (b)(2)

The Company is not aware of any reason why the voluntary suspension should not be granted or of any other information necessary to inform the market about the voluntary suspension.
