(1) The 10,005,987 share options granted in December 2016 comprised an adjustment of 4,082,680 share options on 14 December 2016 as a result of Rights Issue and a new grant of 5,923,307 share options on 15 December 2016. Details of the adjustment and grant are set out in the announcements of the Company dated 14 December 2016 and 15 December 2016 respectively.

(2) The Company granted performance awards to the eligible incentive participants pursuant to the Long Term Incentive Equity Plan ("Plan") adopted by the Company. Details of the grant is set out in the announcement of the Company dated 19 May 2015. Upon vesting, award shares may be issued and allotted to eligible incentive participants (other than those that a Connected Incentive Participants) to satisfy the performance awards, at a ratio of one award share for each performance award. The performance awards granted to the Connected Incentive Participants will be satisfied by on-market purchase of existing shares.

Connected Incentive Participant means the directors of the Company, and/or directors of significant subsidiaries of the Company, who were granted performance awards pursuant to the Plan.
