Legal Settlement with the City of Chicago – Qui Tam Claim

Redflex Holdings Limited (**ASX:RDF**) (**Company**) today announces that the Company, with its U.S. subsidiary, Redflex Traffic Systems, Inc. (based in the State of Arizona in the United States), has signed a release and settlement agreement with the City of Chicago (**City**) to resolve the qui tam civil litigation brought by the City (as plaintiff) in the United States District Court, Northern District of Illinois, Eastern Division (Case No. 15-cv-0827 (N.D. Ill))¹.

With the recently announced Non-Prosecution Agreement by the U.S. Department of Justice and this settlement of the qui tam legal action, the Company has now resolved all criminal and civil matters in the United States arising out of the Company's 2013 investigation.

Mr Adam Gray (Chairman) on behalf of the Redflex Board and the Company, stated that:

"I would like to thank the groups and individuals involved in illuminating and then responsibly addressing the Company's past misdeeds. Having now fully and favourably closed this chapter in the Company's history, we look forward to focusing exclusively upon assisting our customers in improving road and pedestrian safety within their communities, to profitably growing the Redflex business, and to creating value for our shareholders and stakeholders alike".

Under the terms of the agreement the Company will pay to the City USD20 million (with a total of USD10 million payable to the City by December 31, 2017 and the balance payable, in various annual instalments, by December 31, 2023, unless this date is extended under the terms of the agreement).

Redflex operates in 16 countries on 5 continents. The Company intends to continue developing new products and services and focusing on those markets that have attractive growth profiles, unmet market needs, acceptable risk and a high level of market fragmentation.
