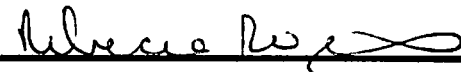

Delta Partners, LP is the investment manager for two private investment funds, Prism Partners, L.P. and Prism Offshore Fund, Ltd (the "Funds"). Charles Jobson is owner of Delta Partners, LP and portfolio manager of the Funds. All 7,750,000 ordinary shares reported for Delta Partners, LP and Charles Jobson are beneficially owned by the Funds. Charles Jobson and Delta Partners, LP have the power to control the voting and/or disposal of the shares. All shares were purchased in the ordinary course of business.
