Notice under ASX Listing Rule 3.10A

In accordance with ASX Listing Rule 3.10A, the Board of iSignthis Ltd (ASX:ISX) (the Company) advises that the following restricted securities will be released from escrow.

Additional Information and Disclosure

The shares issued and now released from escrow are a result of consideration paid to the founders and early stage investors of iSignthis as part of the reverse acquisition of Otis Energy Limited and the re-listing of the Company as ISX. The issue of shares has previously been approved by shareholders and has been disclosed fully in the original Prospectus issued in December 2014 and previous announcements.

The previously disclosed requirements for Performance Rights to be converted to shares have not as yet been met, noting that any shares when issued will however now no longer be in escrow.

Corporate advisors associated with the capital raising, acquisition and re-listing of the Company were issued options that were also disclosed in the Prospectus and approved by shareholders. These options have been converted in the past 24 months but were also subject to escrow for a period of two years from listing.

The Company has been advised by its largest shareholder, iSignthis Ltd (a privately owned company incorporated in the BVI), that approximately 2.3% of its 50.12% holding in ISX shares (representing 1.15% of overall shares) may be transferred to early stage investors.

Managing Director of iSignthis Ltd, Mr N. Karantzis, will continue to retain his holdings as part of iSignthis Ltd (BVI), and has no plans to sell any of his holdings.

Director Disclosure

Mr N. Karantzis will transfer 3,000,000 shares to his Self Managed Superannuation Fund, Ithaki Nominees.
