Terms defined in those documents have the same meaning in this form unless the context otherwise requires.

Step 1: Shareholding details

Use this form if you wish to retain your shares in the Company and not have them sold, free of costs of sale, by the Company in accordance with the Small Holding Sale Facility. This form is to be returned by post to the Registry's address above, to be received by 7.30 am BST on 28 June 2017. If you have recently bought or sold shares your holding may differ from that shown on the reverse of this form. If you have already sold all your shares in the Company do not complete or return this form. If you have more than one share holding on the Company's register and you do not wish to sell your shares under the Small Holding Sale Facility, you should consider consolidating them or submit a Share Retention Form for each shareholding. Companies: In the case of a corporation, this form should be signed by two authorised signatories (e.g. director and company secretary) stating their capacity, or by a director in the presence of a witness who attests the signature or under its common seal.

Deceased estate: Where the holding of shares is in the name of a deceased estate, all executors must sign the form.
