These terms included that the shares were to rank equally with the Company's other ordinary shares, however that the shares were subject to certain restrictions until the shares vested in accordance with the LTIP rules (including that the shares did not carry any voting rights until vesting occurred).

Following the satisfaction of certain

	conditions, the shares have now vested in accordance with the rules for the LTIP and are to be quoted on ASX as fully paid ordinary shares.
