The distribution to the ultimate shareholders of Lion Manager was completed on 27 September 2017, with Mr Widdup being allocated 1,256,742 LSX shares or 32.9% of these shares.

Prior to this distribution, Mr Widdup was deemed to hold 100% of these shares in accordance with section 608 of the Corporations Act 2001.
