Westpac Business Loan

Interest and fees only for 3 years, then repayment in full unless amortised under a new arrangement (solely at Westpac's discretion). Variable rate at 30 September 2017 was 3.30%. Secured by: (i) General Security Agreement over all existing and future assets and undertakings; and (ii) Mortgages over the leases of all 17 childcare centres.

The Company expects to shortly execute an agreement with Westpac to convert the current drawn down balance of \$7,448K from a variable to a fixed rate loan, with effect from 2 January 2018, through to the end of the current loan agreement of 24 November 2019. The exact interest rate will not be known until the agreement has been executed, but is expected to be at a premium to the then variable rate of approximately 60 basis points.
