Cleansing Notice - Issue of New Securities Notice under Section 708A(5)(e) and 708A(6) of the *Corporations Act 2001* (Cth)

On 18 September 2017, Lion Selection Group Limited (**Lion**) announced a placement of approximately 7.8 million fully paid ordinary shares (**Shares**) at 35 cents each to existing and new sophisticated investors to raise \$2.7 million, including Lion's directors subject to shareholder approval under ASX Listing Rule 10.11.

On 21 September 2017, shares with respect to the placement were issued and allotted to shareholders other than the Lion directors.

Following approval of the directors' participation in the placement by Lion's shareholders on 26 October 2017, the remaining placement shares (**Allotted Shares**) were issued an allotted today and an Appendix 3B in respect of these Allotted Shares is attached to this notice.

Lion gives notice under section 708A(5)(e) and 708A(6) of the *Corporations Act 2001* (Cth) (Act) that:

- 1. the Allotted Shares were issued without disclosure to investors under Part 6D.2 of the Act;
- 2. as at the date of this notice, Lion has complied with:
 - (a) the provisions of Chapter 2M of the Act as they apply to Lion; and
 - (b) section 674 of the Act; and
- 3. as at the date of this notice, there is no excluded information of the type referred to in sections 708A(7) and 708A(8) of the Act, which is required to be set out in this notice under section 708A(6)(e) of the Act.
