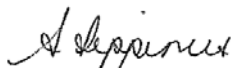

Brickworks has voting power in Washington H. Soul Pattinson & Company Limited (WHSP) of 42.72%. As such, Brickworks is deemed to have a relevant interest in securities held by WHSP in the Company.
