Material terms of employment:

The material terms of the Executive Services Agreement between Kelvin Ryan and Simonds Group Limited (the Company) for the role of Chief Executive Officer and Managing Director (the Agreement) are as follows:

Commencement date	5 March 2018
Term	No fixed term. Ongoing until terminated by either party in accordance with the Agreement.
Total Fixed Annual Remuneration (FAR)	\$600,000
Short term incentive (STI)	Maximum opportunity of \$600,000 per annum, subject to performance, pro rata for the period from the Commencement Date to 30 Jun 2018.
Long term incentive (LTI)	LTI eligibility up to the value of \$600,000 per annum commencing with an FY19 allocation will be offered pursuant to Simonds Group Employee Share Plan. To recognise the time served between the Commencement Date and 30 June 2018, the first allocation of LTI will be increased to \$800,000. LTI participation and terms in future years are at the discretion of the Board.
Notice period / termination entitlements	6 months by either party Employment may be ended immediately in certain circumstances including misconduct, incapacity, mutual agreement or in the event of a fundamental change in the CEO's role or responsibilities. The Company may elect to make payment in lieu of any unserved notice period.
Post-employment restraint	A 6 month restraint provision applies
