Appendix 3Y - Change in Director's Interest

We refer to the Company's Appendix 3Y of today's date, a copy of which accompanies this letter. In relation to Appendix 3Y:

- 1. The sale of 1,632 non-beneficially held shares by Mr Townsing on 18 April 2016 was not reported to the Company due to administrative oversight by him.
- 2. The cancellation by the Company of 400,000 Long Term Incentive Plan shares owned by Mr Townsing on 31 December 2016 was not reported by the Company. However, the Company did file Form 484 with the ASX and ASIC on 31 December 2016.
- 3. These oversights were uncovered as part of a review of Directors interests in the Company.
- 4. The Company is satisfied that the current processes in respect of reporting and notification policies are in place, to ensure compliance with disclosure obligations under ASX Listing Rule 3.19A. Directors are aware of their obligations to notify the Company of any changes in their securities interest and this is also monitored as a standing agenda item at regular Board meetings.
- 5. The Company considers this late lodgment as isolated but will nevertheless regularly remind all the Directors of such obligation and reporting in a timely manner.
